# **Changes to the Property Transfer Tax**

CHBA BC attended the provincial budget lockup on February 16, 2016 in Victoria where changes to the PTT on new housing were announced by the Minister of Finance. The <u>PTT exemption</u> on new construction up to \$750,000 will save purchasers up to **\$13,000** on a newly constructed home and is estimated to provide approximately **\$75 million** in property transfer tax relief for new construction in 2016-17. ### Federal Budget 2016

In February, CHBA BC participated in the Vancouver Centre Federal Pre-Budget Consultations with the Hon. Dr. Hedy Fry. During the discussion, CHBA BC shared the National pre-budget submission messages that focused on housing affordability, including measures that will help first-time home buyers enter the market.
